Section 5. Firefighting measures

Flammability of the product: Flammable in the presence of an oxidizing gas (or air), a source of ignition, and when the concentration of the gas is between the lower and upper explosive limits. Keep away from heat/sparks/open flame/hot surface/oxidizing gas. No smoking.

Section 6. Accidental release measures

Section 7. Handling and storage

Storage: Store at room temperature. Adequate ventilation. Protect from heat and ignition sources.

Engineering controls: Use mechanical exhaust or laboratory fumehood to avoid exposure.
